Clothing Grants will be given to children (on entering Years 7 and 9 only) that are entitled to free school meals and have had written confirmation from their local authority that they will not issue a clothing grant. Entitlement to free school meals is based on parents in receipt of the following support payments : -

• Universal Credit (provided you have an annual net earned income of no more than £7,400, as assessed by earnings

- from up to three of your most recent assessment periods)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part VI of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Child Tax Credit (provided you're not also entitled to Working Tax Credit and have an annual gross income of no more than £16,190)
- Working Tax Credit run-on paid for four weeks after you stop qualifying for Working Tax Credit

It may be necessary for us to contact you to request evidence of your eligibility for free school meals. All Documentation if requested must be current.

Free School Meals Qualification:

 Students will qualify if his/her parent(s) are in receipt of Income Support/IBJSA/ESA/Support under part VI of Immigration & Asylum Act 1999/Guaranteed Pension Credit or Child Tax Credit provided that you are not entitled to Working Tax Credit and have an annual income (as assessed by HM Revenue & Customs) that does not exceed £16,190.00.

<u>A credit for a school lunch (via the restaurant cashless meal system) is allocated on a non-transferable, daily basis to provide a two-course lunch in the restaurant.</u>

Entitlement is dependent on receipt of valid documentation. Free School Meal provision cannot be backdated should your application not be received by us or be otherwise returned. Please therefore ensure that you forward all documentation as soon as possible.

Free School Meal provision is a statutory requirement of the Academy.

Clothing Grant Qualification:

• Students are eligible if they qualify for Free School Meals (as outlined above)

A grant of £55 is made towards the cost of purchasing Academy uniform. This grant is applicable <u>only</u> to students who, in the academic year 2023/2024, enter Year 7 or Year 9 (a. grant is not applicable to those students entering *Year 8, Year 10* or *Year 11*, with the exception of new students who may then be eligible for receipt of grant during consecutive years).

Please note that for Year 7 - the clothing grant will only be issued if your local authority are not issuing clothing grants directly and proof of this from the local authority is attached to this application.

The Academy exercises discretionary powers in provision of this grant. Application is normally restricted to the end of Term 1 for students joining at the start of the academic year.

Sixth Form Bursary

Further Information regarding Student Support

Academy Trip Grant

A one-off grant (worth £95) is available to those students qualifying for <u>Free School Meals</u>. Only one such grant is available during the student's schooling at the Academy. The grant is provided to meet partial costs of student's attendance on approved <u>residential</u> field trips or <u>residential</u> study activities. Form available on application.

Travel assistance is available to Year 7-11 in a limited number of cases where students whose registered home address is more than three miles from the Academy (measured over the shortest walking distance) and where it is also judged that they would have a significantly longer journey to the Academy by using bus and/or tram services for which free usage is currently made available for students with an oyster card within London. This would only apply based on the registered address when first gaining a place at the Academy. Any student who subsequently moves once granted a place at the Academy will not be entitled to any enhanced provision of travel assistance based on their change of address. Distance from the Academy (and not receipt of welfare support) is the only qualification for provision of travel assistance. Form available on application. Those entitled to other forms of support from the Academy can contact Wandsworth Council to see if they can qualify for separate travel assistance.
